HIP:

A 20mph survey from local residents will take place at the APM on the 16^{th of} April 2024. If the residents wanted the 20mph limit on various sections in the Village the cost would have to be provided by the Parish Council which would be approximately £160k. Kent Highways had surveyed Sand Road and commented that there were no improvements needed to the Mirrors.
