6. Public Toilets

Plans were circulated regarding the upgrade of the Public Toilets. Plan B was discussed and due to the size of the current lady's toilet the design does not comply with regulations. It was decided that Plan A would be the best option for the upgrade, this being a gender/neutral toilet to incorporate the disabled facility also. Stipulations included were a separate lock on each of the doors and a panic button to be installed. Approved unanimously.

Common Land/Allotments

Enquiries have been made by Allotment holders regarding Green Houses and Sheds. The Brewer Street Allotments are classed as Garden Allotments due to the size of the plots and falls within the AONB, and next to a conservation area the LPC voted to not allow sheds and greenhouses but would permit Toolboxes and Cold frames.

Events:

Platinum Jubilee – Cllr Stott reported that a mixture of events were being organised and moving along. There is a strong Team supporting the event

HIP:

No response has been received by Kent Highways. Cllr Hamilton reported that she is now the Chairperson for the Joint Transportation Board for Kent, Cllr Nicholas to send the HIP to Cllr Hamilton to chase.
